1976-04-01 Less than a year before his death in 1972, John Berryman signed a contract with his publisher for a book of prose, *The Freedom of the Poet*, for which he had made a selection from his published and unpublished writings. In his draft of a prefatory note, he acknowledged the influence of Eliot, Blackmur, Pound, and Empson on his critical thought, pointing out that "my interest in critical theory has been slight," and

concluding: "But I have also borne in mind throughout: remarks by Franz Kafka ('the story came out of me like a real birth, covered with slime and blood') and Joseph Conrad: 'All the great creations of literature have been symbolic, and in that way have gained in complexity, in power, in depth and in beauty.'" There are thirty-six pieces in all, including not only such justly famous writings on Elizabethan figures as "Shakespeare at Thirty" and "Thomas Nashe and The Unfortunate Traveller" but also "Shakespeare's Last Word" and "Marlowe's Damnations," published for the first time; essays on American writers like Dreiser, Crane, James, Lardner, Fitzgerald, and Bellow, and on poets like Hardy, Pound, Ransom, Eliot, Thomas, Lowell, and Williams; unpublished essays on Cervantes, Whitman's "Song of Myself," Conrad, and Anne Frank; "Thursday Out," an account of a trip to India, and stories, published and unpublished, including "Wash Far Away," "The Lovers," "All Their Colours Exiled," and "The Imaginary Jew."

His plays do not provide answers but attempt to show people how to perform the act of thinking, how to begin to search for answers themselves. Brecht represents the ceaselessness of transformation while at the same time alienating it, interrupting it, making it comprehensible by making it strange. And thereby, in breaking it up by analysis, the possibility emerges of its reconstitution under a new law.

It was impossible to make any one category exhaustive, for such was the mass of material open to me for selection, I might say I was 'fairly betwattled and baffounded'. The only thing to be done was to make my selections fairly representative of the whole. My aim in dealing with the linguistic side of my subject has been to show that rules for pronunciation and syntax are not the monopoly of educated people who have been taught to preach as well as practise them. Dialect-speaking people obey sound-laws and grammatical rules even more faithfully than we do, because theirs is a natural and unconscious obedience. Some writers of literary English seem to enjoy flinging jibes at dialect on the assumption that any deviation from the standard speech must be due to ignorance, if not to vulgarity besides. Since I wrote the last chapter of this book, I read in a criticism of Stanley Houghton's Play Trust the People, this sentence describing the Lancashire 'father an old mill-hand

and the homely mother to match': 'They are both drawn, you feel, to the life, and talk with ease, not to say gusto, that curious lingo which seems to an outsider mainly distinguished by its contemptuous neglect of the definite article', The Times, Friday, Feb. 7, 1913. Now the definite article in north-west Lancashire is t, in the south-west and south t, or th, and in mid and south-east Lancashire th. When this t stands before a consonant, and more especially before a dental such as t, d, it is not by any means easy for the uninitiated to detect the difference in sound between the simple word and the same word preceded by the article, between, for example, table and t table, or dog and t dog. But this is not 'contemptuous neglect' on the part of the Lancastrian! It would be nearer the mark to say that the Lancashire dialect is characterized by its retention of a form of the definite article very difficult to pronounce in certain combinations. Further, I have endeavoured to show by means of numerous illustrations, how full the dialects are

I have also drawn up lists showing the numbers of old words and phrases once common in English literature, still existing in the dialects. Occasionally writers of modern verse seek to restore some of the words of this type to their former position in literary English, thereby causing the reviewer to stumble dreadfully, though he thinketh he standeth. I quote the following from a literary periodical dated May 2, 1913: 'He debates if he shall make "a nest within a reedy brake", or, failing this delectable situation, offers himself a quaint alternative, Or I shall see with quiet eye, The dappled paddock loping by. We had always supposed in our ignorance that "paddock" was a term applied to green fields or pastures. How Mr. ... could have seen a paddock "lope" we do not know, and perhaps it would not be kind to ask him to explain.' To be continue in this ebook
